**A RESOLUTION OF HALFMOON TOWNSHIP, CENTRE COUNTY PENNSYLVANIA  
ACCEPTING DEDICATION OF A PORTION OF SUSAN LANE**

**RECITALS**

**WHEREAS**, Halfmoon Township, Centre County, Pennsylvania (the "Township"), is a municipal corporation organized and existing under the laws of the Commonwealth of Pennsylvania (the "Commonwealth"); and

**WHEREAS**, the Township is authorized by the Second-Class Township Code, at Section 2316, 53 P.S. §67316, to accept by dedication lands dedicated to the Township to be used as public streets; and

**WHEREAS**, an offer of dedication for a portion of Susan Lane has been made by Allen M. Wilson and Heather B. Wilson, to be utilized as public streets; and

**WHEREAS**, the Board of Supervisors of Halfmoon Township desires to accept the dedication of the above-listed lands as roads for public use; and

**NOW THEREFORE**, the Board of Supervisors of Halfmoon Township hereby resolves as follows:

**SECTION 1.** The foregoing recitals to this Resolution are incorporated herein and made a part hereof.

**SECTION 2.** The Halfmoon Township Board of Supervisors does hereby accept dedication by deed a portion of Susan Lane, as more fully described in the attached Deed of Dedication, attached hereto and incorporated herein as Exhibit "A", which contains the appropriate legal descriptions and roadway depiction plats.

**SECTION 3.** Pursuant to Section 2316 of the Second-Class Township Code, 53 P.S. §67316, a copy of this Resolution, including the attached Deed of Dedication, shall be filed with the Clerk of Courts of the Centre County Court of Common Pleas. Upon the filing of the copy of this Resolution and attached Deed of Dedication, the above-listed streets shall become a part of the Halfmoon Township public road system.


**SECTION 4.** All provisions of previous resolutions or ordinances which are contrary to this Resolution are expressly repealed.

**SECTION 5.** If any word, phrase, sentence, part, section, subsection, or other portion of this Resolution or any application thereof to any person or circumstance is declared void, unconstitutional, or invalid for any reason, then such word, phrase, sentence, part, section, subsection, or other portion, or the proscribed application thereof, shall be severable and the remaining provisions of this Resolution and all applications thereof, not having been declared void, unconstitutional, or invalid, shall remain in full force and effect.

**SECTION 6.** This Resolution shall take effect in accordance with law.

**DULY ADOPTED**, pursuant to the authority granted to the Township under the laws of the Commonwealth of Pennsylvania in lawful session duly assembled on the 3rd day of January 2022.
