RESOLUTION NO. 2022-21

**A RESOLUTION OF HALFMOON TOWNSHIP, CENTRE COUNTY,
PENNSYLVANIA, AUTHORIZING THE ENTRY INTO AN INTERGOVERNMENTAL
COOPERATION AGREEMENT WITH PATTON TOWNSHIP FOR ZONING
SERVICES**

WHEREAS, pursuant to the Pennsylvania Intergovernmental Cooperation Act, 53 Pa.C.S. § 2301 *et seq.*, two or more local governments may jointly cooperate in the exercise or in the performance of their respective governmental functions, powers or responsibilities; and

WHEREAS, Section 2507 of the Second Class Township Code, 53 P.S. §§ 65101-68701 provides that the Board of Supervisors may make agreements with other municipal corporations in performing governmental power, duties, and functions; and

WHEREAS, Halfmoon Township desires to enter into an intergovernmental cooperation agreement with Patton Township that will enable Patton Township to provide zoning services to Halfmoon Township in accordance with the terms of said intergovernmental cooperation agreement.


NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Halfmoon Township as follows:

1. The above recitals are incorporated herein by reference thereto.
2. The Board of Supervisors for Halfmoon Township, Centre County, Pennsylvania, is hereby authorized to enter into an intergovernmental cooperation agreement (the "Agreement") with Patton Township for zoning services. A true and correct copy of such Agreement is attached hereto, marked as Exhibit A, and is incorporated herein by reference with the same effect as if it had been set out verbatim in this section.
3. Halfmoon Township is hereby authorized to perform all relevant actions as set forth in the Agreement. These actions shall be taken by the officers and employees of Halfmoon Township as designated in the Agreement.
4. As required by the Intergovernmental Cooperation Act, 53 Pa.C.S.A. § 2307, the following matters are specifically found and determined:

- a. The conditions of this intergovernmental cooperation agreement are set forth in the Agreement referred to in Section 2.
 - b. Halfmoon Township's participation in the Agreement shall be terminable at any time subject to the terms and restrictions of the Agreement referred to in Section 2.
 - c. The Agreement is for the purpose of enabling Patton Township to provide zoning services to Halfmoon Township and the powers and scope of authority delegated are set forth in the Agreement referred to in Section 2.
 - d. Financing shall be provided from the general fund of Halfmoon Township to the extent required by the Agreement.
 - e. Halfmoon Township shall manage the Agreement as set forth in the terms of the Agreement.
5. Repealer. All resolutions or parts of resolutions inconsistent herewith are expressly repealed.
6. Effective Date. This Resolution shall become effective immediately.
