- ***MOTION: Mr. Servello moved to adjust the Township Treasurer's hourly rate to \$28.00 an hour beginning January 1, 2024; Mr. Beck seconded; Vote 5-0-0; Motion Carried.***
- ***MOTION: Mr. Servello moved to adjust the Township Secretary's hourly rate to \$30.00 an hour beginning January 1, 2024; Ms. Hoover seconded; Vote 5-0-0; Motion Carried.***
- ***MOTION: Ms. Hartle moved to change the Public Works Lead position to Roadmaster for formal appointment at the January 2nd, 2024 Board of Supervisors Organization Meeting; Mr. Piper seconded; Vote 4-0-1; Mr. Piper, yea; Mr. Servello, yea; Ms. Hoover, yea; Ms. Hartle, yea; No Nays; Mr. Beck abstained; Motion Carried.***
